RESEARCH INTERESTS

I am presently working with approximately 160 recorded interviews of 45-90 minutes each that I have collected from diasporic Cherokee Nation citizens in Houston, Albuquerque, Sacramento, and the greater Los Angeles areas. The interviews include oral histories of the families of the subjects, as well as information about their civic engagement with the urban Indian community as well as with their tribal government and community. I have used the information gathered in assisting tribal citizens to form regional community organizations and to establish programs at the tribal government to interact in more consistent and substantial ways with the tribal citizens in diaspora.

The interviews represent a very extensive qualitative data set that has already revealed significant ways in which diasporic tribal populations interact and persist beyond or outside of the recognized urban community institutions that have been addressed thus far in the academic literature. As such, they offer many possibilities for future publications and additional research.
